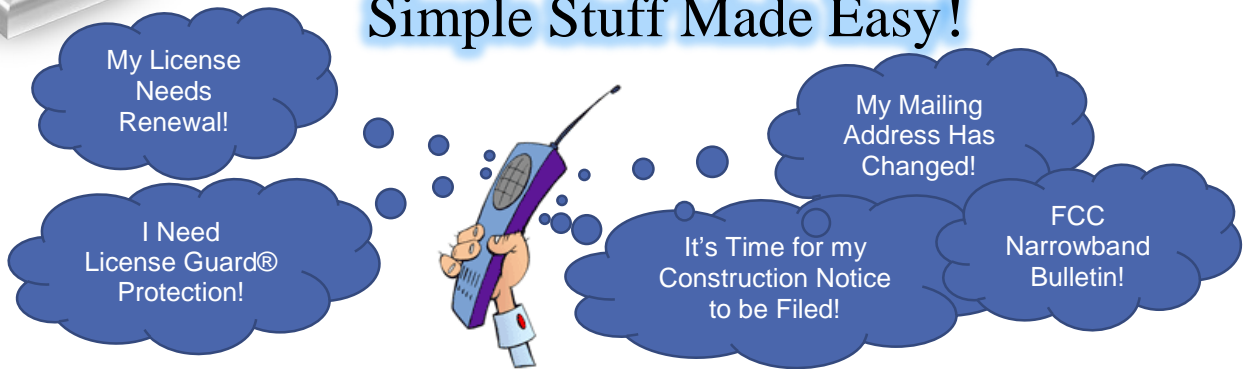

This change must be made as the FCC will not allow any other filings to be processed until the license is 'corrected'. Including Renewals!*
